About the HSE National Central Repository

What is the HSE National Central Repository?

The HSE National Central Repository has been live since July 2023. It is the single trusted source for accessing, storage and document management of approved HSE National Policies, Procedures, Protocols, Guidelines and Clinical Guidelines.

Where is the Repository located?

The Repository is located on the HSE website, no logins or passwords are required, and all documents in PDF format are publicly accessible.

Who developed the Repository?

The Repository was developed in-house by the HSE Digital Communications User Experience Team in collaboration with Health Library Ireland, who also manage the day-to-day operations.





What has the Repository achieved?

- We have strengthened our processes as an organisation in relation to the management and control of National PPPGs
- We now have clear document governance and ownership for the lifecycle of the document.
- We can now monitor all National PPPGs to ensure timely review and update.
- We will reduce unnecessary duplication of such documents in time, particularly relevant as new organisational structures for the HSE Health Regions begin to emerge.
- All National PPPGs must now be developed on the new National Template.
