## Dear Deputy Ryan,

I refer to the above Parliamentary Question which has been referred by the Minister for Children; Equality; Disability; Integration and Youth to the Health Service Executive for direct response. I have requested the Chief Executive Officer for KARE to examine the matter and the following outlines the position.

In response to your query, KARE delivers a wide range of community-based supports to children and adults with intellectual disabilities across South Kildare, West Wicklow and East Offaly. We try to include service users in those activities that have value for them with a focus on inclusive opportunities.

As part of our delivery of services, KARE provide a sports and recreation programme to our adult service users. We do not have a purpose-built sports facility within KARE, and the programme is provided through hiring of community-based facilities and at times, by permission without payment by a number of local clubs.

Year on year we have had issues with securing community facilities, but face challenges accessing these during the day as they are also being sought by other community groups e.g. local schools. Pricing for some venues also limits our access to some facilities. A further challenge is that sessions are adapted to be managed within the venues available rather than

providing full opportunity e.g. skills-based sessions rather than match or competition practice. One way we have met these challenges is through use of sports facilities in Portarlington, Co. Laois i.e. outside our natural area of operation. This naturally is more challenging in travelling to sessions and attendance levels are lower as a result.

The facilities we access within Kildare are listed below.

- Hire Athy ARCH Centre for basketball
- Permission Scoil na Trionoide Athy for Basketball
- Hire Naas K-Leisure swimming Pool for swimming

- Permission Round Towers GAA club Kildare Town for muti-sports activities
- Hire Newbridge Town Football Club for Floorball Skills on Monday evening
