The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which was submitted to the Minister for Health for response.

The staffing environment of the HSE is subject to significant service demands. When a position is vacated, work may be covered through a variety of measures such as redeployment, restructuring or reallocation of work. In addition, where a post has been approved for filling the duties may be covered by agency or overtime in the meantime.

Vacancies for therapy services are changing frequently given current developments in Primary Care with the Community Healthcare Networks and the reconfiguration of the Children's Disability Network teams which are planned to go live shortly.

South East Community Healthcare continues to fill approved posts in line with HSE Recruitment and National Pay-bill Management Framework. Recruitment is ongoing to fill vacancies to ensure continuity of services.
