PQ Question: To ask the Minister for Health the way that it is proposed to address the current challenges that people are experiencing securing consultations with psychiatrists; and if he will make a statement on the matter. -John McGuinness

Dear Deputy McGuinness,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The HSE's Performance Profile Report - PPR (previously known as the Performance Assurance Report) provides an overall analysis of key performance data from Divisions, such as Acute, Mental Health, Older Persons, Disability Services, Primary Care, Finance and HR. The activity data reported is based on Performance Activity and Key Performance Indicators outlined in the current National Service Plan.

The PPR is part of the performance assurance process overseen by the National Performance Oversight Group (NPOG). It monitors performance against planned activity, as outlined in the NSP. The PPR also provides an update to the Department of Health on the delivery of the NSP. The latest reports are available at the following link

Performance Monitoring and Reporting of Services

Latest available preliminary data for mental health services for June indicate the following:

- Nationally there was a decrease of 120 children on the waiting list for community mental health services, from 4,295 in May to 4,175 in June 2022
- As of the end of June, 72.6% of referrals accepted by child and adolescent community teams nationally were offered an appointment within 12 weeks against a target of ≥80%
- Nationally, 90.8% of urgent referrals to CAMHS were responded to within three working days, above the ≥90% target.
- 88.5% of referred patients were offered an appointment within 12 weeks in general adult mental health YTD June 2022 against a target of ≥90%
- 94% of referred patients in Psychiatry of Old Age services were offered an appointment within 12 weeks YTD June 2022 against a target of ≥98%

At national level, monthly engagement meetings are held with each CHO area in order to address areas of operational performance.

Investment in Mental Health Services

The total mental health funding for 2022 amounts to €1,159m. Since 2012, the mental health budget has grown by €452m of which €325m relates to development funding for priority service enhancements. These targeted investments have been directed by national mental health policy as outlined in Vision for Change (2007), Connecting for Life (2015), Sharing the Vision (2020) and in line with the broader Slaíntecare reform programme.

The continued development of Mental Health Services has been aimed at:

 Modernising Mental Health Services that historically were centred on institutional care by building our workforce and investing in fit for purpose infrastructure

- Promoting positive mental health at all levels of society, intervening early when problems develop, and providing accessible, comprehensive and community-based Mental Health Services for those who need them
- Taking a person-centred approach with a focus on enabling and supporting the recovery journey of each individual, based on clinical advice and best practice, as well as lived experience

The table below provides the breakdown of the NSP 2022 new development funding. Mental Health received €24m under Programme for Government 2022 funding. As outlined in table 4 of the HSE National Service Plan, the full year cost of these initiatives amounts to €36.36m in 2023. None of the developments outlined in the table below, relate to the reclassification of historic development and all relate to new developments which have been and will continue to progress in 2022. It should be noted that the first elements of this funding were not drawn down until 1st January 2022 and subsequent budget drawdowns will occur during 2022 according as these posts are progressed.
