## PQ 54198/23

To ask the Minister for Children; Equality; Disability; Integration and Youth the number of children currently on the waiting list to be seen by the Children's Disability Network team in counties Carlow and Kilkenny' the length of time they have been waiting; the number of vacancies on the CDNT currently; if the recent HSE staff embargo means that these vacancies are not being advertised to be filled and/or will not be filled until the embargo is lifted; and if he will make a statement on the matter.

Dear Deputy Smith,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which was submitted to the Minister for Health for response.

I have reviewed the matter and the following is the current position.

The following table outlines the number of children on the waiting list to be seen by the CDNTs in Carlow and Kilkenny including the approximate length of time they have been waiting as of 18<sup>th</sup> December 2023:

In relation to the recent HSE staff embargo, under the current embargo HSE Disability Services have an agreed process in place with HSE National Office whereby they can apply for a derogation on specific critical posts to be advertised and filled. Once HSE National Office has approved these posts for filling, posts can be advertised and recruited. This is an ongoing process. HST National Office have committed to providing a decision to local HSE on the derogations requested within five working days of receipt of the application.
