PQ Question: To ask the Minister for Health the number of people in each LHO area waiting for a counselling appointment in primary care as of 1 December 2023 or the latest date available; and the number waiting less than 6, 6-12, 12-18 and more than 18 months. -Jim O'Callaghan

Dear Deputy O'Callaghan,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Please be advised that the data contained in this response has been received directly from the HSE's National Counselling Service and Counselling in Primary Care [CIPC]. It does not include other counselling services available in the CHO's. The HSE's National Counselling Service provides counselling for adults who have experienced childhood abuse [CAPA] and Counselling in Primary Care [CIPC].

The latest available data¹ for the number of persons on the waiting list for HSE Counselling services is provided in Tables 1 and 2 below by CHO area and time waiting.

The number of people waiting for CAPA at the end of August 2023 was 847 this is in the context of a 20% increase in referrals on the same period in 2022 [1708 referrals in 2023 compared with 1420 referrals at end of August 2022]. 71% of people are waiting 6 months or less for counselling.

The number of people waiting for CIPC at end of August 2023 was 4,406 this is in the context of a 16% increase in total referrals when compared with the same period in 2022 [Number of referrals Jan-Aug 2023 - 13,508; 2022 11,675] 52% of clients are waiting less than 3 months for counselling.

Waiting times for the HSE's National Counselling Service [CAPA and CIPC] vary across the country depending on referral rates, service delivery model, staffing levels and individual geographic factors. The NCS is a demand led service with the counselling contract offered based on the assessed needs of the client. As the number of clients seeking counselling exceeds the number of counselling spaces available at any one time there is a waiting time for counselling.



Due to the recent FORSA Industrial Action, the table below the latest available information on the number of children and young people waiting to be seen by CAMHS as at end of August 2023.

Data is now starting to come in from each CHO area after the suspension of the Industrial Action, however the reportable data position at the time of writing is currently unknown.
