PQ Question: To ask the Minister for Health the number of people who accessed each of the national clinical programmes in mental health, namely ADHD, dual diagnosis, early intervention in psychosis (EIP), eating disorders, perinatal mental health, self-harm/suicide, in the year 2023 and to-date in 2024 in tabular form; and if he will make a statement on the matter. -Colm Burke

Dear Deputy Colm Burke,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Service access is measured by the number of people completing assessment and this is usually collected on a monthly basis provided there is a data system available to the Programme. Any that are available require manual input to excel sheets.

#### **ADHD**

The Adult ADHD NCP updated its data set in 2023 as the previous version did not provide reliable data on numbers of people accessing the service, interventions required and discharges. The updated version has been used since October 2023 and the tables below give the details of the numbers of people who access each service in the form of numbers completing assessment per month.

# **Eating Disorders and Early Intervention in Psychosis**

Not all teams were reporting for a full year in 2023. Data is collected at team level and inputted by clinical staff into excel sheets and analysed on a yearly basis.

# **Specialist Perinatal Mental Health Services**

Not all teams were reporting information and above figures are from 15 out of 19 hospitals

**NCPSHI-** Emergency Departments: Please note that the data provided is a year in arrears, reflecting the most complete annual period available for analysis. The National Database is complete up to 2022.

Data from the Emergency Department (ED) for the NCPSHI is not collected in real time. The data collection process is submitted on a monthly basis, however it is important to note that submissions may encounter delays. Subsequently, each dataset submitted undergoes data validation and cleaning for quality assurance before its addition to the National Database.

#### **SCAN Referrals**

The addition of pre-existing SCAN service and the recruitment of additional posts came under the governance of NCPSHI in 2022. The SCAN data template and data definitions are in the final stage of approval. The Form template will then be designed for pilot testing in a small subset of SCAN sites before finalising and validating the template for full role out from Q4 2024/Q1 2025.

# **Dual Diagnosis**

The Dual Diagnosis adult teams are currently being established Midwest/CHO3 region and CHO5, Cork. Teams to commence limited services in July
