Dear Deputy Kelly,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary question, which was submitted to this department for response.

PQ: 16404/24

To ask the Minister for Children; Equality; Disability; Integration and Youth the number of student placements in CDNT based in Tipperary in the years of 2022, 2023 and to date in 2024, in tabular form.

HSE Response

91 Children's Disability Network Teams (CDNTs) are aligned to 96 Community Healthcare Networks (CHNs) across the country and are providing services and supports for children aged from birth to 18 years of age.

The CDNTs are currently providing services and supports for 45,741 children and strategies and supports for urgent cases on the waitlist where staffing resources allow.

All CDNTs are required to provide student placement programmes, pending staffing resources in place to support the students. All grades of HSCPs on CDNTs are required to supervise students based on individual staff's experience and competency.

The Roadmap for Service Improvement - Disability Services for Children and Young People 2023 – 2026 includes the following action of 55 that will be measured and reported on regularly:

With regard to the question asked, data was gathered in recent months on the number of student placements provided by the CDNTs in the most recent full Academic Year - Sept 2022/2023. Below is the return for CountyTipperary.

A national memo will issue shortly setting an annual target for all CDNTs to provide 1 placement per 2 WTE filled HSCP posts on CDNTs per year, commencing this year. This will increase student placements by 50% to 326 students nationally. In tandem, we will be working with National HSCP Office to develop the scaffolding required to grow and sustain a student placement programme across all CDNTs.
