The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Questions, which was submitted to this Department for response.

PQ 10759/24

To ask the Minister for Health the number of persons on a waiting list for homecare packages, by CHO and LHO, in tabular form; and the number of persons experiencing delayed discharge from hospital due to a delay in accessing homecare.

PQ: 16963/24

To ask the Minister for Health the number of persons on a waiting list for homecare packages in each month in 2023 and to date in 2024, by CHO and LHO, in tabular form. -Róisín Shortall

The Home Support Service is funded by Government to deliver a volume of service each year as approved in the HSE National Service Plan. It is a non-statutory service and access to the current service is based on assessment of the person's needs by the HSE, having regard to the available resources and the competing demands for the service. The volume and type of service provided to each client is based on individually assessed care needs and will vary dependent on the needs identified and the resources available to meet those needs.

Demand for home support continues to increase due to population growth and the increasing dependency of the growing numbers of people aged ≥80years, within the over 65 years' cohort. In the context of increasing demand, priority is given to those being discharged from acute hospitals who are in a position to return home with supports and to those in the community with acute needs. Funding approval is expedited across the system to ensure minimum waiting times

Available waiting list data reflects those that have been assessed and waiting for the provision of Home Support as at 31st March 2024. Please see Appendix 1 which details the number of clients assessed and waiting for Home Support Services at by CHO in 2024. As of this date the total number of people assessed and waiting for a carer to be assigned stood at 5,708. Of the 5,708 waiting on a carer to be assigned, 2,716 are new clients and 2,992 are existing clients waiting on additional service.

With regard to delayed discharges, available data indicates that on 26th March 2024, 411 people were recorded as a delayed discharge. Of the 411, 53 were categorised as Type A Destination Home, with 38 of these people waiting for a carer to be assigned.

Available waiting list data reflects those that have been assessed and waiting for the provision of Home Support.
