The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary question, which was submitted to this department for response.

PQ: 18165/24

To ask the Minister for Children; Equality; Disability; Integration and Youth the number of school OT staff who exist for each of the past five years; and the number of school speech therapist staff who exist for each of the past five years.

#### **HSE Response - Children's Disability Network Teams (CDNTs**

91 Children's Disability Network Teams (CDNTs) are aligned to 96 Community Healthcare Networks (CHNs) across the country and are providing services and supports for children aged from birth to 18 years of age.

Since 2019, more than 610 development posts have been allocated to children's disability services across the country. These posts have been assigned to teams based on a number of factors, including the existing ratio of staff to the number of children with disabilities in each area.

This figure includes 190 posts provided in 2022 as well an additional 136.3 WTEs to restore pre-existing services in 104 special schools. In addition, the recruitment target of 300 Therapy Assistants over the next 2 and ½ years to work on CDNTs will also support children onsite in special schools with additional needs arising from their disability.

With regard to the question asked, the HSE does not collate data regarding the number of Occupational Therapists in schools however, we can provide information regarding therapy posts allocated to Special Schools. Please see the table on next page for current information.

In addition, the HSE and its partner Service Providers are delivering considerable levels of therapy supports to Special Schools, including: Speech and Language Therapy; Psychology; Occupational Therapy; Physiotherapy & Social Work.

With regard to therapy hours provided to Special Schools, from validated, updated information collated for February 2024, 8,235.2 therapy hours were provided per week, which equates to 235.29 WTEs.

# Roadmap for Service Improvement 2023 - 2026, Disability Services for Children and Young People

The HSE's Roadmap for Service Improvement 2023 - 2026, Disability Services for Children and Young People was approved by the HSE Board on July 28th and launched by the Government and the HSE on Tuesday 24th October 2023.

The Roadmap is a targeted Service Improvement Programme to achieve a quality, accessible, equitable and timely service for all children with complex needs as a result of a disability and their families.

It sets out the overall aim for Children's Disability Services, provided by the HSE and its partner agencies, for every child to have a childhood of inclusive experiences where they can have fun, learn, develop interests and skills, and form positive relationships with others in a range of different settings.

The Roadmap actions includes a robust suite of 60 actions, including 21 on CDNT Retention and Recruitment targets, and many of which are now in train.
