"To ask the Minister for Children; Equality; Disability; Integration and Youth if he is aware that the number of children overdue an assessment of need in Cork North Lee is at its highest rate since Q1 2019 ".

Dear Deputy Gould,

The Health Service Executive has been requested to reply to you in the context of the above Parlimentary Question which you submitted to the Minister for Children, Equality, Disability, Integration and Youth for response.

As required by the regulations associated with the Disability Act (2005), applications for Assessment of Need are managed in chronological order across the Cork Kerry Community Healthcare (CKCH) area. The regulations specify that assessments must be processed in strict order based on the date the completed application is received. The figures for Cork North Lee must therefore be considered in the context of the overall number of applications received across Cork and Kerry.

As evidenced by the figures in appendix 1, the number of applications for Assessment of Need in CKCH has increased in 2023 and again in the first quarter of 2024. The increased number of overdue assessments is directly linked to the increase in applications. CKCH is continuing to progress a waiting list initiative to increase the number of Assessments of Need completed in the area.
