PQ 32975/24: To ask the Minister for Health for a breakdown of the number of dentists enrolled with the dental treatment service scheme, by county, in tabular form.

Dear Deputy Crowe,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

Adult medical card holders have access to dental services under the Dental Treatment Services Scheme (DTSS) through care provided by private dentists that hold DTSS contracts with the HSE. The DTSS is a "choice of dentist" scheme which does not require the patient to register with a particular dentist and enables medical card holders to attend any DTSS contractor directly without recourse to the HSE. The number private dentists contracted to the DTSS scheme per CHO and LHO is detailed in Appendix 1 (August 2024).

A process to update the contract numbers was undertaken in June 2023. The HSE corresponded with contract holders requesting they review their availability for provision of care for medical card holders. Several contractors contacted the service to advise that while they remain active on the scheme, they have no availability within the practice for new patients- either private or DTSS.

Oral healthcare services for adults are included in the reorientation of services described in Smile Agus Sláinte (National Oral Health Policy) – the implementation of which is included in priorities and funding from budget 2023.
