**To ask the Minister for Children; Equality; Disability; Integration and Youth the steps being taken to improve disability services in County Carlow; and if he will make a statement on the matter.**

Dear Deputy Murnane O'Connor,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which was submitted to the Minister for Health for response.

*I have reviewed the matter and the following is the current position.*

**Adult Services**

At present across Carlow/Kilkenny the following services are delivered by Adult Disability Services:

- There are 262 Residential placements for adults spread across thirteen agencies
- Delta Services Carlow provide 24 x 48 night beds per year depending on the persons need
- 731 adults in receipt of Day Services with six adults on a waiting list for 2023
- 408 adult receiving Home Support hours to a total of 3,502 hours per week with eight adults on a waiting list

Disability Services continue to work with our partners in Section 38/39 to grow these services for 2024. There is currently planning in place to provide extra Respite Services in Kilkenny with an estimated commencement date of Quarter 1 2024. Alternative models to enhance Disability Services in the community by way of increased support hours within the home setting. Increasing capacity within current respite services and offering alternative models of delivering Respite Services will be prioritised.

**Children's Services**

HSE Children's Disability Services has undergone significant reform and restructuring over the past two years and the implementation of the Progressing Disability Services (PDS). The core focus of this change is to ensure that children and their families, with complex interdisciplinary needs, will receive an appropriate and accessible family centred service.

In Carlow, there is one Children's Disability Network Team (CDNT). This team is located in Bethany House, Barrack Street, Carlow and is led by the HSE. Across this team there are 294 children with complex disabilities registered for Clinical Services. 50 of these children have active Individual Family Support Plans (IFSPs). 230 children are waiting on an initial contact. All children are prioritised for services based on clinical risk and within available resources.

Filling of vacant clinical posts across this team is the HSE's top priority in order to address the children's needs on waiting lists and to provide clinical services to new applicants once



accepted to the teams. South East Community Healthcare (SECH) under the current embargo and HSE disability services recently received a derogation to interview and recruit all vacant clinical posts. These interviews were completed on Friday 16<sup>th</sup> February 2024 and job offers from this recruitment campaign are in train.

In Carlow, Family Forums have commenced to provide information to families on the services they are providing and the resources they have available to them. These forums also provide information on the CDNTs universal and targeted supports that include information sessions and workshops to support families either in the absence of direct clinical supports or to compliment direct clinical supports. The next Family Forum in Carlow is scheduled for 14<sup>th</sup> May 2024.

The CDNT in Carlow continues to receive referrals and continues to grow their service provision by sharing resources and looking for new and alternative models of service delivery to extend their current services to all children in need of a clinical service.
