PQ 20720/24: To ask the Minister for Health the number of people on a waiting list for dental and orthodontic treatment, by age, CHO and wait time, in tabular form.

Dear Deputy Shortall,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

The HSE Community Dental Service targets children in key school years (6th, 2nd and 4th classes), offering them dental examinations, preventive care and restorative treatments for conditions noted, and is resource dependent. As part of targeting of resources, each dental service maintains a commitment to urgent/emergency treatment for the relief of pain, infection, and the sequelae of trauma.

Access to funded orthodontic treatment is limited to those children with the most severe and complex orthodontic treatment needs. The Modified Index of Treatment Needs (Modified IOTN) system is used in all regions to determine if a child will be accepted for treatment, children whose treatment need is assessed as being in Grade 4 or Grade 5 of the Index are offered treatment with the HSE. I wish to advise the Deputy that the data is not available as requested. The tables below detail the latest KPI data for the Dental and Orthodontic Service (end Q1 2024). The reported metric for the Dental Service is the number of new oral health patients in target groups attending for scheduled assessment.

The National Service Plan supports the implementation of the Government's National Oral Health Policy, Smile Agus Sláinte, including the development of comprehensive oral healthcare packages for roll-out to children aged from birth to seven years of age. I trust this information is of assistance to you, but if you require further clarification please do not hesitate to contact me.
