Dear Deputy Moynihan,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary question, which was submitted to this department for response.

PQ: 41898/24

To ask the Minister for Children; Equality; Disability; Integration and Youth the details of the increase in funding for specialist community based disability services (details supplied) in each CHO area since 2020; the estimated funding to be provided for each CHO area in 2025; the new and additional services provided in each CHO area since 2020; the new and additional services to be provided in each CHO area in 2025; and if he will make a statement on the matter.

Details Supplied: with regard to the €3.2 billion of current funding for Specialist Community Based Disability Services in 2025, representing an overall increase of €1.2bn since 2020.

HSE Response

HSE Disability Services is allocated funding on an annual basis to provide a range of services throughout the country. Funding is spent in line with nationally agreed policy for disability services, whilst at the same time endeavouring to maximise value. Services include Residential and Respite Services, Day Services, PA and Home Support Services, and Therapeutic Supports.

There has been year on year increased funding provided for Disability Services. The Table below demonstrates the increased funding for Disability services each year Table 1

Specialist Disability Services - Current Provision

The HSE provides and funds a wide range of specialist disability services to those with physical, sensory, intellectual disability and autism. Services focus on supporting and enabling people with disabilities to maximise their full potential, as independently as possible. Current policies are based on the principles of person-centredness to ensure insofar as possible that the supports for a person are based on individual assessed need, will and preference and to support people to remain as close to home and connected to their community as possible. Services are provided in a variety of community and residential settings in partnership with service users, their families and carers and a range of statutory, non-statutory, voluntary and community groups. Specialist Disability services are delivered through a mix of HSE direct provision as well as through over 400 voluntary Section 38 and 39 funded service providers, and private providers.

Specialist Disability Services has been allocated €2.9 billion in 2024. This funding is providing Services throughout the country across HSE Areas and is spent in line with nationally agreed policy for disability services, whilst at the same time endeavouring to maximise value.

- Approximately 60% of the resources available are allocated to provide a range of residential services to 8,600 people with a disability.
- A further 20% is targeted at the provision of day services to 23,000 people in 1,041 locations around the country. These supports are provided by approximately 95 service provider agencies (predominately Section 38 and 39 agencies).
- The remaining 20% provides: Respite Care Services to over 6,000 people; 5.3 million Personal Assistant and Home Support hours to over 10,000 people; Children's Therapeutic Supports provided by 93 Children's Disability Network Teams (CDNTs); and Other Support Services

In addition to the above level of service delivery, Specialist Disability Services is also involved in a number of key change projects:

- Implementation of the Action Plan for Disability Services 2024 2026, which was prepared by the Department of Children, Equality, Disability, Integration and Youth and aims to provide a costed pathway for stable sustainable service development in the context of meeting our obligations under the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD);
- Implementation of the National Neuro-Rehabilitation Strategy and Managed Clinical Rehabilitation Network;
- Implementation of the Pilot Personalised Budget Demonstration Project;
- Development of national outcomes monitoring system for Disability Day Services;



- Development of a new procurement framework for Disability & Mental Health private residential placements;
- Oversee the national U65 implementation project team to address the recommendations of the Wasted Lives report and the development of pathways for under 65s in nursing homes to transition to appropriate supports in the community;
- Implementation of a Disability Service Home Support Authorisation Scheme and the development of a Disability Home Support Procurement Framework;
- Development of a roadmap for the improvement and enhancement of Personal Assistance (PA) Services on an equitable national basis;
- Development of Standards for Home Sharing Service;
- Implementation of the Service Improvement Programme for the Autistic Community;
- Developing Sustainability Impact Assessments of large complex Section 38 and 39 organisations Sustainability Impact Assessments (SIA Projects) are undertaken to address the critical operational
 challenges of individual S39 and S38 service providers and define a pathway and action plan to deliver long
 term stability and sustainability (i.e. strategic change in line with transformation agenda) of services.
- System design, development, specification, testing, training, and application support for all admin and clinical staff across all 12 Lead Agency CDNT organisations for the Children's Disability Network Teams Information Management System (CDNTIMS);
- Implementation of the National Medicines Management Framework & commencement of QQI Level 5 course;
- Update, expansion and implementation of the Health Passport;
- Development of a National Thalidomide Liaison Function, including the establishment of a National Thalidomide Office.

Disability Service Provision 2025

Estimates Process and Multi Annual Investment



Each year the HSE participates in the Estimates Process with the Department of Children, Equality, Disability, Integration and Youth and makes a submission for additional monies to meet the health and social care needs of the population it services.

The Disability Service makes submissions for additional funding for all services including Day, Residential, Respite, Home Support/PA hours, Multi-Disciplinary Posts and Neuro Rehab monies as a key element of its submission. Any new funding secured is allocated to the CHOs to provide services to those with the greatest need (priority basis).

The HSE makes every effort to secure multi-annual investment for services via the Estimates process and is very conscious of the need to deliver disability policy on a more sustainable footing given the significant levels of need for increased and more effective services and supports to enable people with a disability to live independent lives in their own community.

While Budget 2025, published on Tuesday the 1st October 2025, announced a funding allocation of €25.76 billion to the Department of Health and a Disability Services Budget of over €3 billion, the granular detail regarding the allocation of funding for various services will not be known until the Service Plan for 2025 is published.
