PQ 43641/24: To ask the Minister for Health the number of advanced nurse practitioners employed each year (June) from 2016 to 2024, in tabular form; and if he will make a statement on the matter.

Dear Deputy Smyth,

I refer to your recent parliamentary question in relation to staffing which was forwarded to the Health Services Executive (HSE) by the Department of Health for direct reply.

The Deputy will be interested to note that at the end of June 2024, employment levels show there were 148,256 WTE (equating to 166,675 personnel) directly employed in the provision of Health & Social Care Services by the HSE and Section 38 hospitals & agencies and of which 720 WTE (750 personnel) were Advanced Nurse/ Midwife Practitioners. The Deputy will be interested to note that this figure represents a 164% increase in reported staffing over the period covered by this enquiry. However, I should point out that a small proportion of this is likely attributable to better reporting as some staff were reported on their pay grade e.g. Assistant Director of Nursing.

Details as requested, in tabular form for June 2016 to June 2024 for each grade Advanced Nurse/ Midwife Practitioners (together with candidate grades, which were introduced to track staff in education / training) are as set out in the following table:
