I refer to your parliamentary question below which has been forwarded to me for attention.

PQ 1920/25 - To ask the Minister for Health the number of children with complex orthopaedic conditions on waiting lists with Children's Health Ireland; his plans for making treatment abroad accessible for these children; and if he will make a statement on the matter.

## Children's Health Ireland (CHI) Response:

## Orthopaedics:

According to the latest NTPF figures (23rd of January 2025), there are 3451 children on the Children's Health Ireland (CHI) orthopaedic waiting list. There are 786 children actively waiting on the inpatient or day case orthopaedic waiting list. These figures include both children with complex and non-complex needs.
