Dear Deputy Cummins,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 1977/25:

To ask the Minister for Health the number of respite beds available in each county, for the years 2020 to 2024 inclusive, in tabular form; and if he will make a statement on the matter.

Within Residential Care Facilities for the Older Person short stay beds are categorised under a number of headings including Respite beds.

Designated short stay beds for respite purposes may be interchangeable depending on service needs and can be categorised as follows:

- **Respite Beds**
- **Dementia Specific Respite Beds**
- Convalescent Beds

The table below outlines the number of beds designated for respite/convalescent care in public nursing units as at December of each year 2020 to 2024.
