PQ Question: To ask the Minister for Health the estimated cost of fully staffing three new eating

disorder teams. -Darren O'Rourke

Dear Deputy Rourke,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

In January 2018, the HSE published a National Model of Care for Eating Disorders (MOC) in partnership with College of Psychiatrists' of Ireland and Bodywhys. In the absence of a pre-existing dedicated eating disorder infrastructure or strategy, this Model of Care document has been developed in order to guide the provision of high quality, accessible and value for money eating disorder services in Ireland. Key recommendations include:

- The development of a national network of dedicated eating disorder teams embedded within the mental health service.
- A stepped model of outpatient, day patient and inpatient care provision based on clinical need.
- The development of a skilled, trained workforce.

The National Clinical Programme for Eating disorders (NCPED) aims to establish an ED network (8 adult teams and 8 CAMHS teams) in accordance with the agreed Model of Care 2018. These consultant led multidisciplinary teams provide specialist eating disorder assessment and treatment in the community and are the foundations of delivering quality eating disorder care across the stepped model of care. Today (January, 2024) there are 5 CAMHS teams and 6 adult ED teams at various stages of development across the HSE, with an additional adult team currently in development and recruitment. As part of Budget 2025, funding is approved for a new CAMHS team and new adult team.

The breakdown of costs of an Adult Eating Disorder Team serving a population of 500,000 is detailed in Table (1). The current full year cost for one new team is € 1,819,047, for 3 new teams €5,457,141. This does not include capital costs to house a team in a suitable premises.
