Dear Deputy O'Rourke,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and outlined the position as follows.

Please see below outlining the number of persons accessing disability services in the community in County Meath under Adult and children services, home support and respite. Please note that the figures provided below are accurate as of the date of this communication, figures provided for Children's Disability Network Teams (CDNT) are based on December 2024 CDNT Metrics.

#### Meath Disability Adult Services:

Currently have 3,295 clients on database, people known to the team.

Active caseloads at present:

ID Clients: 892

Physical and Sensory Clients: 1,338

These clients are receiving services from one or more of Meath Disability Adult Team departments at present i.e. Occupational Therapy, Physiotherapy, Nursing, Social work, Acquired Brain Injury and Psychology
