It is a requirement of the HSE donations policy [effective January 2023] that a report is made annually to the board on the book value of HSE donations.

Board members are asked to consider and note the total book value of donations by the HSE in 2023 which amounted to €98,092.50.

Brief summary of link to Board objectives.

- 1. The Donations Policy enables the HSE to contribute to the whole of government approach in Ireland's International Development Policy ('A Better World') by reaching "the furthest behind first".
- 2. Repurposing surplus stock and decommissioned equipment and ambulances no longer in use contributes to our obligations in minimising waste, repurposing and contributing to the climate change agenda.
- **3.** Operating a donations programme is a priority objective in the HSE Service Plan 2023.
- 4. Supporting government, the Department of Foreign Affairs and the Department of Health to respond to humanitarian crises such as Ukraine and Sudan. In 2023, the Donations Programme received funding from the Ukraine fund. This funding has been repeated in 2024 and provides security to plan and develop a long term, sustainable donations programme that meets the Board's objectives, i.e., improving climate change by minimising waste and repurposing items and being prepared to respond to a humanitarian crisis, where appropriate.
- **5.** Operating a donations programme is a priority objective in the HSE Service Plan 2024.

Background - provide context in order to ensure that the Board fully understand the issue.

- 1. The Board approved the HSE Donations Policy in January 2023. The policy requires that an annual report of donations is made to the HSE board and that any donations that exceed €2million book value in a calendar are brought to the Board for approval.
- 2. Many items have no book value as they have been used or have been written off. Decommissioned equipment and ambulances have zero book value. New surplus items have a book value and this is recorded for each donation. The book value for donations in 2023 was €98,092.50.
- 3. A separate commercial value is given to each donation, in accordance with international shipping requirements and to reflect the value of HSE and Ireland's contribution. The commercial value for donations in 2023 was €2,480,109
