### Memo to GPs re LAIV Schools Programme

Dear Doctor,

The Live Attenuated Influenza Vaccine (LAIV) Schools Programme 2024/2025 is due to commence on 7<sup>th</sup> October 2024. Thank you to those who have returned the Schools LAIV Template.

#### Confirmation of primary school participation

Some schools may have been contacted by multiple providers. Having reviewed the returned forms, there appear to be some instances where details of the same primary school have been provided by more than one contractor. It is important at this stage that GPs confirm their arrangements with the schools in which they will facilitate vaccination to avoid duplication in the provision of the LAIV on-site.

### **Stock and Ordering**

Stock allocation of Fluenz nasal spray suspension (LAIV) to GPs for school-based vaccination will be based on the information provided on the planning forms as outlined above. Stock will be available to order through the online portal with deliveries occurring on a fortnightly basis as per National Cold Chain Service (NCCS) delivery calendar. It is envisaged that the first fortnightly cycle of deliveries will be completed in advance of the LAIV schools programme commencement. In order to maximise stock management efficiency, and in light of the short expiry dates of these vaccines, sites are requested to only order what is anticipated to be used between deliveries.

GP's are advised to schedule their primary school clinics in accordance with the delivery calendar and any additional requests for vaccine can be made by contacting NCCS at vaccines@udd.ie.

**Note**: it is advisable to confirm arrangements with schools in advance of vaccine ordering.

# **Data Entry**

A valid PPSN is required for the administration of HSE Influenza vaccines.

As there are many providers of flu vaccinations, it is essential that all vaccines given are recorded promptly onto the IT systems that sends data to COVAX, so that clinical records are kept up to date and two doses are not administered in error.

Vaccinators may receive a phone call from HSELive to clarify data quality (DQ) items. HSELive is part of the HSE and the team work closely with the NIO and contracting office to seek clarification to resolve DQ issues. There is dedicated line for GP's to ring HSELive, in relation to DQ issues which is: 01 2408786.
