### What the ADMCA does

Discontinues new applications for admission to Wardship from 26 April 2023

#### What the ADMCA does not do

- Provide for Authorisation of Deprivation of Liberty
- Provide for end-of life treatment decisions
- Provide for safeguarding actions

### **Deprivation of Liberty: European Convention on Human Rights**

The Court reiterates that the right to liberty is **too important** in a democratic society for a person **to lose** the benefit of Convention protection **for the single reason that he may have given himself up to be taken into detention** ..., especially when it is not disputed that that person is legally incapable of consenting to, or disagreeing with, the proposed action.

## **Deprivation of Liberty: Ireland**

#### Key points:

- Does the patient truly want to leave?
- If she truly wants to leave and she has capacity, she must be allowed to leave
- If she lacks capacity, hospital has no general right to hold her
- But a brief detention is allowed to get the matter to the Court

AC v Hickey and Ors [2019] IESC 73



#### **Inherent Jurisdiction**

- General definition: Implied powers of the Court exercisable by judges to make decisions in the interests of justice, where no statutory regime exists
- An "ill-defined and unregulated territory" per McKechnie J In re JJ [2021] IESC 1
- Affirmation of continuance in the ADMCA, s. 4(5)



### Increased Reliance on the Inherent Jurisdiction

Total Cases (to 16 September 2024): 230

- 78 in 2023
- 152 in 2024

Total Orders (to 16 September 2024): 935

- 284 in 2023
- 651 in 2024

Most common applicant

- HSE
- Dublin Hospitals

Most common basis

- Nursing home admission
- Once-off treatment decisions


#### The Inherent Jurisdiction List

- New Practice Direction (HC 128): In operation from 2
  October 2024
- Inherent Jurisdiction (Capacity) List sits every day at 10 am
- Applications heard by President or nominee
- Provision for immediate hearing of very urgent ex parte applications



### **Hearings under the Inherent Jurisdiction**

- Voice of the Person
  - Legal Representative
  - Guardian ad Litem (significant efforts to ascertain will and preferences)
  - Remote Attendance
- Application of ADMCA Principles:
  - Past and present will and preferences
  - Least restrictive alternative
  - Respect for rights
  - Act always for benefit of person

- Development of Legislative
  Protection of Liberty Safeguards
- Original consultation Paper: 2018
- Expected new consultation: 2025
