



Section B Information Specific to Registered Nurses and Registered Midwives for the administration of COVID-19 vaccine-to people aged 12 years and older

Statutory Instruments No. 698 of 2020, No. 8 of 2021, No.43 of 2021 identifies registered nurses and registered midwives as one of the professions that can administer the COVID-19 vaccines, subject to approval of an education programme by the regulatory body concerned.

In order to administer the vaccine, registered nurses and registered midwives must be familiar with the most up to date version of the COVID-19 master medicine protocol for people aged 12 years and older. Registered nurses and registered midwives must also have completed the Competency Assessment Form included in this section. The medicine protocol and Competency Assessment Form are available at www.immunisation.ie.

Professional Qualifications, Training, Experience and Competence Required

NIO COVID-19 Vaccination Training Programme – People aged 12 years and older accessible on www.HSElanD.ie4. An approved <i>Basic Life Support for Health Care Providers Course</i> within the last two years (i.e. Irish Heart Foundation (IHF)). Recertification is required every two years5. Initial <i>National Anaphylaxis Education Programme for Health Care Professionals</i> accessible on www.HSElanD.ie followed by a two hour classroom based skills workshop. Recertification is required every two years by completing the on-line <i>National Anaphylaxis Education Programme for Health Care Professionals</i> accessible on www.HSElanD.ie6.
