In preparation for the implementation of these updated rules there was a working Group established in November 2022 This working group went through all our current practices, and what the change would mean for us. Each committee member were delegated roles. All current documentation with regard to seclusion and restraint were modified. Restrictive practice clinical practices forms for seclusion and restraint specific to CAMHS were established and rolled out. From January 2023 all requirements were put in place. A statement about the effectiveness of the approved centre's actions to eliminate, where possible, and reduce physical restraint

Since the implementation of the updates of the Codes of Prectice on the Rules Governing the Use of Restraing on the 1st of January 2023 to June 2024 We have had 17 episodes of Physical Restraint - from Jan to June 30th the total number of restraints were 4 (all the same pateint), from July to dec 2024 there was a total of 11 retrainints (9 on the same pt post admission, 2 on separate female pateints), Jan 2024 to June 2024 - 2 restraint on the sameperson post admission.

This is a reduction of 5 restraints from 2022.

The service of of the belief that the buy in from staff to attend all the training, as well as change their attitudes ie utilising the safeward interventions, has definately impacted on the fact that there has been a reduction in the episodes of restraint. So far this year, the number of restraints has halved for 2023 stats.

To date the approved centre has been compliant with the new requirements in the updated codes of practice. Staff have completed the training as mentioned above on HSEland to ensure awareness of these changes as well as attended presentations to better their knowledge. They have read and signed the updated seclusion policy , and the Restrictive Practices reduction stategy and Policy

However, although the changes have been implemented, given the volume of changes, not all elements of the documentation requirements were compliant in our most recent inspection. In order to rectify this, we have now implemented a Restraint care pathway document which is a composite set of documents which includes all elements of the requirements of the retrictive practices, and prompts staff to fill out and update documents as required ie update of ICP post restraint.

We have not had any restraints since this document was implameneted, but it will be audited once utilised.
