There are three residents that require mechanical restraint due to enduring risk. The mechanical restraint used is lap bets for two residents and bed rails for the other resident bedrails.

Mechanical restraint is prescribed by the consultant, reviewed weekly by the MDT. There is practice committee in place that meet quarterly. This committee ensures that all aspects of the code of practice are upheld including level of observations, human rights, bathroom access, movement, access to outdoor activity. The committee also reviews if the risk continues to be enduring based on risk assessment and management. Minutes of these meetings are retained on file for review. All notification are returned as per policy/code to the MHC
