During 2023 the Dept of Psychiatry, Portlaoise Oversight and Review Committee (DOPPORC) for the reduction of Seclusion and Physical & Enduring Mechanical Restraint was formally set up in March 2023 pursuant to requirements of the Mental Health Act 2001-2018, September 2022. This committee meets monthly to determine if there is compliance with Mental Health Commission regulations and policy and identify areas requiring improvement and learning and develop actions and time frames.

As part of the work of this committee a number of policy documents were developed or revisited in line with the new Mental Health commission requirements to include the following:

- 1. development of a Policy of the Reduction of the use of Seclusion and Physical & Enduring Mechanical Restraint,
- 2. development of a Policy on the Rules Governing the Use of Mechanical Means of Bodily Restraint

There were fewer than 5 episodes of the use of Mechanical Means of Bodily Restraint in 2023 and these were reviewed by the DOPPORC and were in compliance with the MHC rules and the DOPP's own policies.

The DOPP has been effective in reducing mechanical means of odily restraint in 2023 and will continue to work towards further reducing this into 2024 and beyond.
