A statement about the effectiveness of the approved centre's actions to reduce and, where possible, eliminate mechanical means of bodily restraint

The Elm Mount Approved Centre (AC) has implemented several effective measures to reduce and, where possible, eliminate the use of mechanical means of bodily restraint, demonstrating a commitment to the dignity and well-being of patients in our care. The AC has prioritised the adoption of de-escalation techniques and other non-restrictive interventions, providing ongoing training for staff to manage challenging behaviors without resorting to mechanical restraints, thereby fostering a more therapeutic and non-restrictive environment.

Comprehensive monitoring and review processes ensure that any use of restraint is thoroughly documented and evaluated, promoting continuous improvement and accountability. Additionally, Elm Mount AC promotes a culture of patient-centered care by actively involving patients in their treatment plans and decision-making processes, which helps address underlying causes of distress and reduces the likelihood of situations escalating to the point where restraints might be necessary. These measures underscore Elm Mount AC's dedication to maintaining a safe and supportive environment while upholding the rights and dignity of its patients, reflected in the decreased frequency of restraint use and positive feedback from both patients and staff.

The Elm Mount AC aims to fully comply with the MHC Rules governing the use of mechanical means of bodily restraint. The AC adheres strictly to all regulatory guidelines and standards, ensuring that any restraint intervention is conducted in accordance with established PPPGs. This includes thorough documentation and review of each episode of restraints, ensuring transparency and accountability. The AC has established a Restraint Reduction Oversight Committee with a relevant multi-disciplinary team (MDT) representative to review each restraint episode. This committee plays a crucial role in evaluating restraint episodes, identifying areas for improvement, and sharing learnings with the wider team. This diligent adherence to rules and the committee's proactive oversight not only safeguards patients' rights and dignity but also promotes a culture of safety and continuous improvement within the facility.

The Elm Mount AC aims to fully comply with CHE MHS policy on Rules Governing the use of Mechanical Means of Bodily Restraint. This policy emphasises minimising and, where possible, eliminating the need for such restraints through proactive and preventative measures. The AC ensures all staff are trained in de-escalation techniques and other non-restrictive interventions, aligning with the CHE MHS Policy. Comprehensive monitoring and regular reviews are conducted to evaluate each restraint episode, ensuring adherence to the AC's Policy . Additionally, the centre conducts quarterly audits to assess and identify areas for improvement and implements Corrective and Preventative Actions (CAPA) based on these findings. The multidisciplinary team develops individualised care plans that include less restrictive alternatives and conducts reviews of all restraint episodes. This commitment to compliance and continuous improvement underscores the centre's dedication to providing a safe, dignified, and therapeutic environment for all residents.

CHE MHS policies prioritise non-restrictive interventions, ensuring that physical restraint is used only as a last resort. We provide regular staff training in de-escalation techniques and crisis intervention strategies, equipping our team with the skills to manage challenging behaviours effectively and compassionately. Each patient benefits from individualised care plans developed in collaboration with patients, their families and MDT, ensuring that their unique needs and preferences are met, thus reducing the likelihood of situations escalating to the point where physical restraint might be considered. Additionally, we integrate alternative therapies such as sensory room, art therapy, yoga therapy, and mindfulness practices into our care regimen. We promote mental and physical well-being and proactive measures to prevent behaviours that might lead to restraint. Our commitment to continuous monitoring and data-driven strategies allows us to maintain transparency, accountability, and a focus on continuous improvement. By prioritising patient-centred care and innovative practices, we have significantly decreased the frequency of physical restraints, enhancing the overall well-being of our patients.
