



Approved Consultant Posts for Recruitment

The following information details the new and replacement consultant posts recommended for approval each month. It should be noted that there is often a significant period of time between recommendation of approval of a consultant post through the Consultant Applications Advisory Committee (CAAC) to the commencement of the recruitment process and ultimately the recruitment of a Consultant to a post.

Recruitment to HSE Consultant posts is conducted by the Public Appointment Service (PAS) with HSE funded sites conducting their own recruitment directly. Definition of Status	
Title of Post	The qualifications specified for consultant posts to reflect the Specialist Division of the Register of Medical Practitioners are listed in the attached link: https://www.hse.ie/eng/staff/leadership-education-development/met/consultantapplications/quals1/
Post Type	New post refers to a new consultant post or an additional post for an established department. Direct Replacement post refers to a consultant post which has become, or is due to become, vacant with no significant structure changes to the post. Replacement and Restructure post refers to a consultant post which has been become, or is due to become, vacant. Changes have been made to the structure of the post – e.g. working hours, location of post.
Post Reference Number	This is the unique post identification number.
Principal Clinical Site	Principal Clinical Site is the clinical site with the majority of hours.
Other Clinical Site	Where a post is split/across more than one clinical site this is referred to as “Other clinical site”. Not applicable means that the post has all its hours based in the principal clinical site.
Approval Date	The month in which CAAC / National HR recommended the post for approval.

Consultants in Public Health Medicine - Public Health Areas Defined

Public Health Area A – This area includes the current Department of Public Health North East and CHO 9. The postholder may be based in Railway Road, Navan, Co. Meath or Dr. Steevens Hospital, Dublin 8.
Public Health Area B – This area includes the current Department of Public Health Midlands and CHO 7. The postholder may be based in Arden Road, Tullamore, Co. Offaly or Dr. Steevens Hospital, Dublin 8.
Public Health Area C – This area includes the current Department of Public Health South East and CHO 6. The postholder may be based in Lacken, Co. Kilkenny, or Dr. Steevens Hospital, Dublin 8.
Public Health Area D – This area includes the current Department of Public Health South. The postholder may be based in Cork, Co. Cork.
Public Health Area E – This area includes the current Department of Public Health Midwest. The postholder may be based in Mount Kennett House, Henry Street, Limerick.
Public Health Area F – This area includes the current Department of Public Health North West and Department of Public Health West. The postholder may be based in Letterkenny, Co. Donegal, Sligo, Co. Sligo or Galway Co. Galway.
