## **COVID-19 Booster Vaccination Campaign Spring 2025**

Dear Doctor,

I refer to <u>Circular NCO-06-2025</u> Seasonal Vaccination Programme update, dated 5<sup>th</sup> February 2025. It has been confirmed that the spring booster campaign commences on **3<sup>rd</sup> April 2025** and will continue until the end of **May 2025**.

The following groups are eligible for a COVID-19 Spring booster:

- Those aged 80 years and older
- Those aged 70-79 years who did not receive a COVID-19 vaccine in the preceding 12 months
- Those in long term care facilities for older adults
- Those aged 6 months and older with immunocompromise associated with a suboptimal response to vaccination.

The most recent NIAC recommendations are available here.

Note: For the purposes of the Spring Campaign, a booster should be made available for those aged 70-79 years who have not received a COVID-19 Vaccine since 30<sup>th</sup> June 2024.

Prior to administering any vaccines, you should use the Vaccination History Search application to check vaccination status and avoid administering a duplicate vaccine. Recommended intervals are as per the NIAC guidance; however, those eligible may be offered the spring booster at a 3 months interval after their last COVID-19 vaccine or infection to ensure they get their booster before the end of May.

Additionally, pregnant women, in the appropriate stage of pregnancy and where the appropriate time since last dose of vaccine has elapsed, remain eligible for booster doses throughout the year. Primary vaccination courses for those in recommended groups, continue to be available, regardless of the time of the year.

Those eligible aged 12 years and over, will be able to avail of booster doses through participating GPs and Pharmacies. As in previous campaigns, HSE COVID-19 Vaccination Teams will provide vaccinations to eligible residents in long-term care facilities for older adults, those aged under 12 years, and the housebound.

The COVID-19 vaccine remains free of charge to those eligible cohorts outlined, and is not available privately.

# Vaccines & Ordering

- The COVID-19 vaccine which will be used for the spring campaign is Comirnaty® KP.2.
- One box of vaccines (60 doses) will be available to order online. If additional doses are required they may be requested by emailing <u>vaccines@udd.ie</u>. Please bear in mind the eligible cohorts for the Spring Booster Campaign when placing orders.
- COVID-19 vaccines can be ordered online from <a href="https://www.ordervaccines.ie/">https://www.ordervaccines.ie/</a>. Review your delivery calendar to confirm order cut-off dates and delivery dates. Note that four times annually there is a three week gap between vaccine deliveries, with one scheduled mid-March.
- Reminder: Comirnaty Omicron XBB.1.5 COVID-19 mRNA Vaccine will be removed from GP Practice Management System (PMS)/GPVax effective from 31<sup>st</sup> March 2025. Any outstanding vaccine records and claims relating to the above product must be entered by 5pm on 31<sup>st</sup> March 2025 as it will not be possible to submit after this date.
- Any expired vaccine stock should be returned to NCCS using the normal process with your next delivery –see <u>vaccine-return-form-2028.pdf</u>.
- The HSE has endeavoured to obtain supplies of Nuvaxovid (Novavax) vaccine for those who have contraindications to mRNA vaccines or prefer non mRNA vaccines. However as Nuvaxovid (Novavax) is not currently available in Ireland, the HSE is continuing its efforts to obtain supplies of the vaccine. People requiring a non mRNA vaccine can be advised to contact HSELive on 1800 700 700 who will make the necessary arrangements when Nuvaxovid (Novavax) becomes available.

### **Recording Vaccines**

Please ensure timely recording of vaccine administration in your GP PMS/GPVax. Refer to <u>Guidance Note</u> <u>2</u> Completion of Vaccination Records on IT Systems.

Note: The <u>HSE Health App</u> is a new digital health service from the HSE that gives patients who use the app secure personalised access to their health information including COVID-19 and flu vaccine records.
