Subject: HR Circular 013/2024 - Extension of Parent's Leave and Benefit to

9 Weeks

Dear Colleagues

I wish to advise that <u>Statutory Instrument No. 300/2024 Parent's Leave and Benefit</u>
<u>Act 2019 (Extension of Periods of Leave) Order 2024</u> has extended the duration of Parent's Leave and Benefit from 7 weeks to 9 weeks from 1 August 2024.

The additional two weeks of Parent's Leave applies to children who are under the age of 2 in August 2024, or adoptive children who have been placed with their parents for less than two years as of 1 August 2024

Eligible employees may avail of their parent's leave entitlement in a block of 9 consecutive weeks or in separate weekly blocks over a longer period within the first 2 years of the birth or adoptive placement of a child. Employees who had taken 7 weeks'

parent's leave prior to 1 August 2024 will now have an entitlement to an additional 2 weeks' leave.

An employee who is a relevant parent in more than one capacity in respect of a child is entitled to 9 weeks' parent's leave in total. Where the birth of a child is part of a multiple birth or a person adopts two or more children at the same time, the employee is entitled to 9 weeks' parent's leave in total.

The entitlement to parent's benefit is subject to the eligibility criteria and conditions set down by the Department of Social Protection and details are available on their here.
Public health service employees are not entitled to payment from their employer during parent's leave.

The main provisions of the 2019 Act (as amended) are outlined in section D of HSE HR Circular 18/2021.
