Appendix 1

Details of Agreement on Pay and Conditions of Employment for Family Support Workers

- From 1/7/98, full-time Family Support Workers will be paid at the equivalent of the Group 8 (Non-Nursing) scale (see Appendix 2). Part-time workers will be paid at the Group 8 hourly rate (see Appendix 2). Please note that there are separate scales for those workers who are paid through the paypath scheme and those who are not.
- Assimilation to the new scale will be by way of corresponding points (e.g. a Family Support Worker who is in his/her 1st year of employment will move onto the 2nd point of the new scale).
- The Health Service travel and subsistence rate will apply.
- Public transport costs should be paid where suitable services are available.
- Employers should give contracts of employment to part-time Family Support Workers to cover their tenure of office and conditions of employment.
